# RUGA SETTLEMENTS: A STRATEGY FOR SOCIO-ECONOMIC ACTIVITIES AND CONFLICT RESOLUTION AMONG FARMERS/HERDERS IN NIGERIA

#### Abstract

The neglect of Grazing Reserves Law of 1965 by the succeeding governments after the First Republic in Nigeria has led to farmers and herders clashes/conflicts due to struggle over limited scarce resources such as lands, water, crops and grasses. The clashes/conflicts made the incumbent President Muhammadu Buhari to approve the introduction of Ruga settlements plan in Nigeria. The Niger State government has already taken a lead through the rehabilitation of about 30, 000 hectares of the Bobi Grazing Reserve in Mariga Local Government Area and intends to increase the game reserve to 35,000/45,000 hectares. The objective of this study is to investigate the feelings of the residence concerning socio-economic importance and conflict resolution strategy using Ruga settlements plan in Bobi Grazing Reserve in Mariga Local Government Area of Niger State. The sample size of study was 100 respondents who are residents of the five villages (Oro, kamfanin-bobi, Durgu, Ukuru and Tashan-Bala) around Bobi Grazing Reserve. The major findings of this study are that 58% of the residence are aware of the Ruga settlement plan; 52% of the respondents are of the opinion that Ruga settlement plan will not reduce farmer-herders clashes and 71% of the people observe that Ruga settlement plan will create job opportunities for most unemployed youths in the area. In addition, 53% of the residence say that Ruga settlements plan will improve the quality of meat/milk production; 51% of the respondents indicate that Ruga settlement plan will increase income generation to people of the area and 90% of the respondents see Ruga settlements plan as a way to provide formal education to the children of farmers/herders in villages around the Bobi Grazing Reservein Mariga Local Government Area of Niger State. The study concludes that Ruga settlement plan around Bobi Grazing Reserve will reduce conflicts problem between farmers and herders but it will not eliminate it completely as the problem is an age long issue. However, the scheme will improve socio-economic activities of the people residence in the area as business activities will improve. The research recommends that Niger State government should do more of enlightenment campaign to sensitize the people living around Bobi Grazing Reserve as they do not believe that the Ruga settlement plan by government will eliminate the problem of farmers/herders clashes in Nigeria.

### 1. Introduction

Ruga settlements or Fulani settlements plan in Nigeria known as cattle ranching is not new, it is an old wine in a new bottle. This is because the idea of Ruga settlements is traceable to First Republic immediately after the independence in 1960 by the Former Premier of the Northern Nigeria, Sir Ahamdu Bello (the Sadauna of Sokoto) (Waheed, Abiola, Nzor & Nda-Isaiah, 2019). To be precise, Northern Region of Nigeria passed Grazing Reserves Law in 1965. The

law stipulates that minimum of 10% of the country's land area to be legally acquired and constituted into grazing reserves for lease allocation to grazers (Premiumnewsnigeria, 2019). Ruga settlements means allowing herdsmen to settle down permanently in a particular area to prevent open grazing or roaming about with cattle that may cause farmers/herdsmen clashes. The reasons for Ruga settlements initiatives among others are to address the issue of insecurity; provide quality of meat and milk production for healthier nourishment; provide former education to children of nomads; provide employment opportunities to citizens; attract investments opportunities to the country and generate revenue for the nation (Uche, 2019). It is important to note that 90% of Nigeria cattle and by-products comes from pastoralists (herdsmen) and contributes between 6% and 7% to GDP. Agriculture overall contributes up to 23% to the national GDP (Mohammed, 2016).

Historically and up till the first Republic era of 1965 in Nigeria, farmers (agriculturalists) and herders (pastoralists) enjoyed a fairly symbiotic relationship. Farmers provide grain and other farm products for herders' livestock. Herders' livestock provided farmers with manure to fertilize their farm lands. This is because farmers engage in crops farming and herders engage in animal husbandry with little or no clashes. At those periods, the population of Nigeria was small and number of people that were involved in the farming activities for consumption and business purposes were also small. The small number of farmers couple with few population and a lot of uncultivated lands allow herdsmen to wander about with their cattle freely. As the population of Nigeria increases over time and more lands cultivated, the herders' routes of open crazing were taken over by the farmers causing herders/farmers clashes. The clashes resulted in the loss of lives and properties due to neglect of the grazing reserves law by subsequent governments in Nigeria after the First Republic (Premiumnewsnigeria, 2019). Therefore, clashes/conflicts emanate in pursuing limited scarce resources (farmlands, grasslands and water spots for animals) by both the farmers and herdsmen (Ofem & Inyang, 2014).

The major causes of farmers-herders clashes in Nigeria among others include lack of inadequate grazing areas and conflict of interest over land resources among others.; cattle theft and attack; increase in human and livestock population; increase in agricultural practices; destruction of crop among others (Ofuoku & Isife, 2010; Adogi, 2013; Nformi, 2014). The adverse effects of farmers/herders' clashes include loss of human and animal lives; destruction of crops; reprisal attack which affects innocent souls; displacement of persons and animals; and distrust between herdsmen and farmers (Oli, Ibekwe & Nwankwo, 2018).

As the clashes between herders and farmers deepen, the idea of *Ruga* settlements was re-echo during the Fourth Republic in Nigeria when the Former President Goodluck Jonathan budgeted about N10 billion for the scheme and the money could not be found for its implementation (Waheed, Abiola, Nzor & Nda-Isaiah, 2019). Nowadays, herdsmen are seen doing open crazing in schools, stadium surroundings and road sides as their crazing roots were taken over by the farmers because of the increase in number of. people that engage in faming activities.

In order to ameliorate the problem and stop the roaming of cattle about, Federal Government of Nigeria (FGN) under the leadership of President Muhammadu Buhari approved the reintroduction of *Ruga* settlements in the six Geo-Political Zones of the country on 17<sup>th</sup> January, 2019 (Shehu, 2019). The scheme shall be implemented in seven pilot states which are prone to

farmer-herder clashes in the country. Such states are Adamawa, Benue, Kaduna, Plateau, Nasarawa, Taraba and Zamfara (Shehu, 2019). The re-introduction of the scheme by FGN follow the initiatives of the National Economic Council (NEC) presentation under the National Livestock Transformation Plan (2018-2027). It is conceptualized to permanently stop the agelong herders-farmers crises and to massively develop the livestock industry (Shehu, 2019). The scheme was formerly pronounced to Nigerians by formal Minister of Agriculture and Rural Development, Chief Audu Ogbeh on 12<sup>th</sup> May, 2019 that the President had approved the *Ruga* settlement implementation and the scheme will start immediately due to crises (Uche, 2019).

After the official pronouncement of the implementation plan of the *Ruga* settlement initiative, there were series of condemnations from some Nigerian in both Northern and Southern part of the country especially the Yorubas and Igbos from South as well as few Northern Christian faithful. The condemnations were followed with a lot of protests by some citizens in some states like Benue and Taraba states. The citizens of these states think that the FGN is planning to take over the lands and no part of their lands will be ceded to the government. The protests made the FGN to suspend the idea of *Ruga* settlements initiatives plan on 3<sup>rd</sup> July, 2019 and made it voluntary as forcing the scheme on states may cause more clashes between herdsmen and farmers (Nnamdi, 2019).

In 2019, the FGN made the issue of *Ruga* settlements plan voluntary to states, and some states like Gombe, Kano and Niger States have showed interest in the scheme due to its economic importance (Matane, 2019; Olasupo, 2019; Umoren, 2019), what will be the response of Nigeria, concerning the issue of *Ruga* settlements plan?

Nigeria has over 40 million hectares of grazing lands, but just about 3 million hectares are specifically tagged as grazing reserves established under the Northern Region Grazing Reserves Law of 1965. Also, out of 417 grazing reserves, only about 113 grazing reserves have been gazetted. The need to permanently rehabilitate herders is of paramount important (Premiumnewsnigeria, 2019). It is essential to note that Niger State Government has already taken a lead through the rehabilitation of about 30, 000 hectares of the Bobi Grazing Reserve in Mariga Local Government Area and intends to increase the game reserve to 35,000/45,000 hectares (Shittu, 2018; Matane, 2019) because of the anticipated socio-economic importance.

At this juncture, the empirical evidences about the feelings of the residence concerning socioeconomic importance and conflict resolution strategy using *Ruga* settlement plan in Bobi Grazing Reserve is not available to the best of my knowledge. This made the research new and different from other past studies. However, empirical studies concerning farmers/herders clashes and conflict are available in few numbers such as research by Ofuoku and Isife (2010); Bello (2013); Mwamfupe (2015); Baba & Abeysinghe (2017); Chinwokwu (2017) and Oli *et al.* (2018).

The above identified gaps make the researcher to investigate the feelings of the residence around the Bobi Grazing Reserve concerning the issue of *Ruga* settlements plan in the Niger State. This study will be beneficial to potential academic researchers, area of contribution to knowledge and citizens of the Federal Government of Nigeria.

### 2. Literature Review

# Conceptual Review

Ruga settlements which herdsmen are allowed to settle down permanently in a particular area to prevent roaming about with their cattle that may cause farmers/herdsmen clashes is long overdue. Just for two years (2016 and 2017), the farmers/herders clashes have caused wanton destruction of lives and properties as shown in Table 1.

Table 1 is a clear evidence of unjustified killings, mayhems and destruction of properties by farmers and herdsmen. The Federal Government of Nigeria is on the right path to come up with the idea of Ruga settlement as it has constitutional right to protect lives and properties.

### Empirical Review

Exact empirical studies concerning the issue of Ruga settlements initiatives were not available. However, related empirical studies include the work of Ofuoku and Isife (2010); Bello (2013); Mwamfupe (2015); Baba & Abeysinghe (2017); Chinwokwu (2017) and Oli et al. (2018). Ofuoku and Isife (2010) empirically assessed the causes, effects and resolution of farmers and nomadic cattle herders conflict in Delta State, Nigeria. Study randomly sampled 80 farmers and 20 nomadic cattle herders from randomly selected communities. Data were collected using structured interview schedule. The result of structured interview revealed that the causes of farmers and nomadic cattle herders conflicts are destruction of crops, contamination of streams

by cattle, zero grazing of land, disregard for local traditional authorities, female harassment, harassment of nomads by host communities youths, indiscriminate bush burning, defecation of cattle on roads, cattle theft, and straying of cattle. The socio-economic effects of the conflicts result to reduction in crop yield and income of farmers/nomads displacement of farmers, loss of lives and properties and loss of products in the storage. The result of T-test statistic shows differences in the responses of farmers and nomads in the respect to the causes of the conflicts. The research suggested that the mechanism of local development plans should be established to reduce such conflicts. However, the study used interview method which is qualitative in nature and non-parametric T-test statistic.

Bello (2013) examined herdsmen and farmers conflicts in Yobe State -Nigeria in North-Eastern Nigeria. Four-stage cluster random sampling procedure was used to select respondents for the research. Out of the 17 local government areas (LGAs) in the state, 14 LGAs are mostly associated with farmer-herdsmen conflict. Out of these 14 LGAs, ten were randomly selected. In each of the 14 LGAs, five farming communities were randomly selected making a total of 50 villages. Ten arable crop farmers were randomly selected from each village, thus giving a total of 500 farmers. In each of 14 LGA, 250 cattle herdsmen were also randomly selected for data collection. This was done by randomly selecting five herdsmen from ten transit camps in each LGA. In all, 750 respondents were selected for the quantitative data collection. Descriptive statistic (frequencies and percentages) was used to present and analyse the data collected. The study indicates that the necessity to provide food crops and animal as well as raw materials for industry and export in order to meet ever-growing demands has led to extensive use of land. Also, the study reveals that conflicts have demonstrated high potential to exacerbate the insecurity and food crisis particularly in rural communities where most of the conflicts are situated with repercussions nationwide. The study concluded by stating that the periodical struggle for scarce ecosystem resources is what had degenerated into violent conflicts in Yobe State between Fulani herdsmen and farmers. But the research is conducted in Yoba State and not Niger State of Nigeria.

Mwamfupe (2015) examined the persistent crises between farmers and herders in Tanzania. The study used interview method to collect information (2012-2014) from respondents who are farmers, herders, and district level officials in Kilombero, Kiteto, Rufiji andKilosa districts. Focus group discussions were conducted to collect information on conflict resolution mechanisms and the persistence of the conflicts in their areas. The study found that the major factors for the persistence of conflicts between farmers and herders include policy deficiencies and contradictions; insecurity of land tenure; inadequacy of capacity of the local institutions; corrupt practices; poor coordination in resettling the migrants; inadequate capacity in village land use planning; and the heavy-handed approaches used to resolve the conflicts. The study concludes that the root cause of the conflicts is the lack of security of land tenure to smallholder farmers and herders who hold and use unsurveyed land that is liable for alienation through acquisition and encroachment. Unless the government reviews its land policy to ensure security of land tenure land grabbing and corrupt practices will escalate and lead to further conflicts. However, the study utilized interview method that requires the researcher to be present for interviewing.

Baba & Abeysinghe (2017) studied the effective strategies for resolution and management of farmers-herdsmen conflict in the North Central Region of Nigeria. Closed ended questionnaire was administered on 60 respondents systematically selected from the six states in the North Central Region of Nigeria. Each state is represented by 10 respondents chosen from one of its local government area. Among every 10 respondents chosen, there were 4 farmers, 4 herdsmen and 2 Local Government Officials. The respondents were selected from the local government areas which have recorded more and frequent conflict between Farmers and Herdsmen in their respective state. Data collected through the questionnaire are analyzed using descriptive statistic (frequencies and percentages) and correlation statistic. The study shows that strategies of conflicts resolutions are building religious harmony and tolerance between Farmers and Herdsmen in the region since it is one the causes of conflicts. Another strategy is the establishment of effective mechanism for settling disputes between Farmers and Herdsmen will serve as an effective strategy for resolution and management of conflict between the two agricultural land users in the North Central Region of Nigeria. But the study administered the questionnaire to only 60 respondents from the six states in the North Central Region of Nigeria which is grossly inadequate. Chinwokwu (2017) studied glamorization of Fulani herdsmen's criminality and its implications on national security in Nigeria. The study revealed that government inaction to caution, arrest, prosecute or punish the criminal activities of the Fulani herdsmen is evidence that government is behind their activities. It also viewed government silence as shrouded in inert motive that is not far from expansionist ideology. Therefore, the study suggested that efforts of government must ensure that the activities of Fulani herdsmen are checked to ensure peace and security across the country. However, the study is term paper analysis and not empirical in nature.

Oli *et al.* (2018) examined the herdsmen and farmers conflict in Nigeria using historical documents. The study found that some of the factors that usually led to clashes are limited or unavailability of grazing fields and farm lands; grazing on crops; long-standing disagreements; lack of access to farm or grazing fields; and scarcity of fresh water. Consequently, loss of human and animal lives; destruction of crops and properties; displacement of persons and animals; distrust between herdsmen and farmers; rising anti-Fulani sentiment; and breakdown of peaceful relationship with many communities in some parts of the country. The study concludes that until this issue is amicably resolved and absolute cooperation among the conflicting parties enhanced; food and national security would continue to be threatened. Therefore, the study recommended amongst others that government should establish cattle grazing fields in the six geo-political zones of the country and out-law open grazing of cattle. But the study is based on term paper analysis and the ongoing study is empirical

From the review of the previous studies, there is no exact study on Ruga settlements. This is a research gap that this study intends to fill to contribute to the frontier of knowledge by investigating the feelings of the residence concerning socio-economic importance and conflict resolution strategy using Ruga settlements plan in Bobi Grazing Reserve in Mariga Local Government Area of Niger State.

### Conflict Theory

The proposed study shall anchor on conflict theory. This is because conflict occurs among two opposing groups or classes (farmers and herdsmen) who struggle over scarce resources (land,

crops/grasses and water) (Idowu, 2017). The conflict theory postulates that two opposing groups in the society always struggle over limited or scarce resources. Each group struggles to attain or acquire more resources as they are scarce. Every group tries to protect its own interest, hence, blocking the progress of another in accessing the resources (Idowu, 2017;Oli *et al.*, 2018).

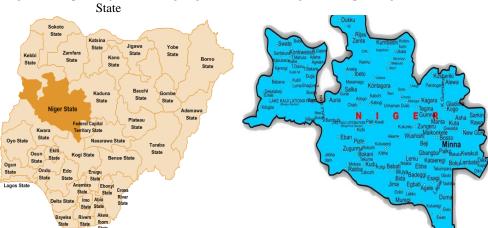
### 3. Methodology

This is a survey research design in which primary data are collected through questionnaire instrument. For the reason that questionnaire is the best instrument for this kind of study (Cavana, Dalahaye&Sekaran, 2001). The research study is conducted in five villages (Oro, kamfaninbobi, Durgu, Ukuru and TashanBala) around the Bobi Grazing Reserve in Mariga Local Government Area of Niger State. The Bobi Grazing Reserve covers about 30,000 hectares of land (Shittu, 2018). It was established 50 years ago by the Federal Government of Nigeria (FGN) and handed over to the Niger State government in year 2006 (Shittu, 2018).

The sample size of the study consists of 100 respondents who are residents of the five villages around Bobi Grazing Reserve in Mariga Local Government Area of Niger State (see the map of the study area in Figure 1 and 2). Bobi Grazing Reserve in Mariga Local Government Area is selected among 25 local government area of Niger State because the state government is interested in the project. The 25 local government areas of Niger State are Agaie, Agwara, Bida, Borgu, Bosso, Chanchaga, Edati, Gbako, Gurara, Katcha, Kontagora, Lapai, Lavun, Magama, Mariga, Mashagu, Mokwa, Munya, Paikoro, Rafi, Rijau, Shiroro, Suleja, Tafa and Wushishi

The study randomly sampled 100 residence who are people living in the five villages around Bobi Grazing Reserve. Questionnaire instrument is used to collect primary source of data from the residence who are farmers and herders living in the five villages. The questionnaire is divided into two sections in close-ended form. Section A is demographic information of the

respondents and Section B is questions relating to the subject matter. The questionnaire is subjected to both validity and reliability tests. The validity test of the questionnaire instrument is done through an expert is the field of management science discipline. Also, the validity and reliability tests were done through the pilot tests of the questionnaire to see whether the instrument is capable of sourcing required information.

Twenty (20) copies of questionnaires each were administered to the people of Oro, kamfaninbobi, Durgu, Ukuru and TashanBala by the research assistant who is an indigene of the Mariga Local Government Area of Niger state. The 100 copies of questionnaires (20 questionnaires multiply by 5 villages) was completed correctly and returned. The returned questionnaires was used for data analysis.

In addition, Statistic Package for Social Science (SPSS version 23) is the statistical software package for data screening and analysis. Since this research is studying a phenomenon known as *Ruga* settlement initiative, descriptive statistic (frequency and percentage) is utilized to present data collected and subsequently analysed.

### 4. Data Presentation and Analyses

This section presents frequency distributions of the data collected in percentages and analysed to draw conclusions.

Table 1 indicates that 85 respondents representing 100% are male while 15 respondents representing 15% are female. This means majority of respondents are male that fill copies of the questionnaire concerning the issue of socio-economic importance and conflict resolution strategy using *Ruga* settlement plan around Bobi Grazing Reserve in Mariga Local Government Area of Niger State.

This means majority of the residence say that *Ruga* settlement plan around Bobi Grazing Reserve will not reduce farmer-herders clashes.

Table 11 shows that 90 respondents representing 90% say "Yes" that *Ruga* settlements plan will provide formal education to the children of farmers/herders residence around Bobi Grazing Reserve. Nevertheless, 10 respondents representing 10% say "No" that *Ruga* settlements plan will not provide formal education to the children of farmers/herders residence around Bobi Grazing Reserve in Mariga Local Government Area of Niger State. This implies majority of the residence say that *Ruga* settlement plan around Bobi Grazing Reserve will provide formal education to the children of farmers/herders in the area.

Discussion of the Major Findings

The major findings of this study in relation to the demographic information is that majority of the respondents are male, married, youths, acquired informal education in Arabic/Quranic studies and herders. These respondents live in five villages (Oro, kamfaninbobi, Durgu, Ukuru and TashanBala) around Bobi Grazing Reserve in Mariga Local Government Area of Niger State.

In addition, the major findings in relation to the research questions are that 58% of the residence are aware of the Rugasettlement plan. Second, 52% of the respondents are of the opinion that Ruga settlement plan will not reduce farmer-herders clashes. The result is similar to the findings of Bello (2013) that observed the periodical struggle for scarce ecosystem resources is what had degenerated into violent conflicts. Mwamfupe (2015) found that the major factors for the persistence of conflicts between farmers and herders include policy deficiencies and contradictions; insecurity of land tenure; inadequacy of capacity of the local institutions; corrupt practices; poor coordination in resettling the migrants; inadequate capacity in village land use planning; and the heavy-handed approaches used to resolve the conflicts. Third, 71% of the people observe that Ruga settlement plan will create job opportunities for most unemployed youths in the area. Fourth, 53% of the residence say that Ruga settlements plan will improve the quality of meat/milk production. Fifth, 51% of the respondents indicate that Ruga settlement plan will increase income generation to people of the area. This is different from the findings of Ofuoku and Isife (2010) that found the socio-economic effects of the conflicts result to reduction in crop yield and income of farmers/nomads displacement of farmers, loss of lives and properties and loss of products in the storage. Also, Baba &Abeysinghe (2017) indicated that strategies of conflicts resolutions are building religious harmony and effective strategy for resolution and management. Lastly, 90% of the respondents see Ruga settlements plan as a way to provide formal education to the children of farmers/herders in villagesaround the Bobi Grazing Reserve in Mariga Local Government Area Niger State. Therefore, majority of the respondent observe that Ruga settlement plan around Bobi Grazing Reserve will reduce conflicts problem between farmers and herders but it will not eliminate it.

### 5. Conclusion and Recommendation

From the beginning of the Nigeria independence in 1960, farmers/herdersconflicts have been minimum compare to wanton killings and mayhems in different parts of Nigeria in recent years from 2015 to 2019 in Nige state, Benue state, Taraba state and so on. This is because Grazing Reserves Law of 1965 was neglected by succeeding governments after the first republic government that promulgated the law. The study findings among others are that *Ruga* settlement plan around Bobi Grazing Reserve in Mariga Local Government Area of Niger State will not eliminate conflicts problem between farmers and herders. However, the *Ruga* settlement plan will improve socio-economic activities of the people residence in the area as business activities will improve. The prior expectation of the research result is that majority of the residence will welcome and accept the proposed *Ruga* settlement plan by the Niger State and Federal Government of Nigeria because of its socio-economic importance. The study concludes that *Ruga* settlement plan around Bobi Grazing Reserve will reduce conflicts problem between farmers and herders but it will not eliminate it completely as the problem is an age long issue. However, the scheme will improve socio-economic activities of the people residence in the area

as the business activities will improve. The research recommends that Niger State government should do more of enlightenment campaign to sensitize the people living aroundBobi Grazing Reserve as they do not belief that the *Ruga* settlement plan by government will eliminate the problem of farmers/herders clashes in Nigeria.
