Analysis of Stream and Well Water Quality for Domestic Use in Minna Metropolise, Niger State, Nigeria

Abstract

This study analyzed stream and well water quality for domestic use in Minna Metropolise, Niger State, Nigeria. Water sources have become critically contaminated due to anthropogenic activities. Samples of stream and well water were taken for laboratory test. The laboratory tests analysed twenty four constituents (5 physical elements, 5 metal elements, 13 chemical elements and one microbial element) that were compared with World Health Organization (WHO) standard for domestic drinking water to ascertain the safety of the water. The result showed that temperature rise (29.2°C) of water was common in both stream and well waters. Other parameters were within the WHO recommended allowable limits. The study has suggested environmental education and water treatment strategies to curb the menace of contaminated water in Minna city, Niger State, Nigeria without further delay.

1. Introduction

Water is one important resource for the survival of human on planet earth. The global use of water has risen to six-times in the past century and is growing 1% per annum since 1980s (Xu, Yang et al., 2022). Thus, increased water consumption is facing serious challenges in this contemporary period. The advent of industrial sector, practice of agriculture and life in urban centers have adversely resulted to pollution of water sources such as rivers and well waters, which are necessary for life. The effect of polluted water has negatively impacted on human health and sustainable social development. Over 80% of industrial and municipal wastewater is discharged to the environment without being treated having adverse effect on human health and the ecosystem. This effect is higher in less developed countries where sanitation and wastewater treatment facilities are severely lacking (Yassin et al., 2006).

Contaminated water has greater effects on human health. UNESCO World Water Development Report of 2021 showed that 829,000 people die per year from diarrhea caused by unsafe drinking water, sanitation and poor hygiene; and 300,000 children under the age of five die per annum because of contaminated water and poor hygiene (Yassin et al., 2006). Tap water, bottled water, stream and well water are sources of gastrointestinal disease. Lack of water and sanitation services can raise the incidence of diseases such as cholera, trachoma, schistosomiasis and helminthiasis (Payment, 2007). A study from

developing country has shown a clear relationship between cholera and contaminated household water (Gundry, 2004). Thus, in addition to disease, unsafe drinking water and poor environmental hygiene can result to gastrointestinal illness, inhibiting nutrient absorption and malnutrition especially in children.

Globally, bodies of water are the main reservoir and common disposal of waste and substances from industries, public sewage as well as discharge from agricultural wastes. Both surface and underground water dissolve natural minerals and chemicals generated by humans. These waste and effluent can alter the physical, chemical and biological components of the water bodies thereby degrading the quality of water (Sandoyin, 2001). Sometimes, water bodies easily assimilate waste in contact with them without actually deteriorating to a large degree (Fair, 2001). The first effect of waste is to degrade the physical quality of water. This is followed by biological degradation by variety of living organisms in the body of water (Gray, 2009). The main sources of pollution in wells, streams, rivers, surface and underground water is through human activities caused by poor water management and uncultured living habit. This can be accelerated by unhealthy practices by factories, industries and corporate institutions leading to discharge of untreated waste and effluent to the water bodies (Akpan, and Offem, 2003)

Proliferation of industries and unhealthy use of chemicals fertilizers as well as pesticides are causing heavy chemical loading in the water bodies. The use of these chemicals cause varied pollution to the aquatic environment resulting to lower water quality and death of water biota (Firozia and Kumar, 2012). These contaminants can be in the form of microbes, different inorganic contaminants, variety of pesticides, herbicides, radioactive substances and organic chemical contaminants (Steve, 2009). Also, pollution of coastal water bodies could result to changes in nutrient levels surplus, biomass and diversity of organism, bioaccumulation of organic and inorganic compounds and alteration of trophic interaction among species (Gupta and Shukle, 2006). Most water on the earth surface is saline in nature, few are freshwater which has made it a scarce commodity due to pollution and overexploitation of the water resources (Patil and Tijare, 2001; Singh and Mathur, 2005).

2. Methodology

This study took samples from Minna stream and well water for laboratory test. The laboratory tests analysed twenty four constituents (5 physical elements, 5 metal elements, 13 chemical elements and 2 microbial elements) were compared with World Health Organization (WHO) standard for domestic drinking water to ascertain the safety of the water. Samples were taken to laboratory for test on physical and chemical suitability of each water source. Table 1 shows the parameters, description and methodology used in the laboratory tests.

3. Results

Table 2 showed results of stream collected samples in wet and dry seasons. Thus, the stream temperature in wet season had 28.7°c which was lower than stream temperature in dry season having 29.2°C. The WHO recommended limit is 23.5°C indicating that stream temperature was above WHO limit. Manganese concentration in dry season was 1.09mg/l which was above 0.2mg/L recommended by WHO standard. Therefore water from stream source could be dangerous for human health and it should be treated before domestic use.

The study also revealed in Table 3 that well water samples in wet and dry seasons were below WHO standard permissive level. Thus, chloride concentration in wet season was 17.96mg/L and 17.1mg/l in dry season which was below WHO standard. Temperature was the only parameter that was above WHO standard limit with 27°C in wet season and 29.20°C during dry season.

This study is contrary to the findings of John (2015) who carried out water quality assessment of tropical stream in University of Abuja, between March to May, 2014. The parameters investigated in the laboratory were electrical conductivity, pH, total solids, total hardness, permanent hardness, temporary hardness, dissolved solids, suspended solids, dissolved oxygen, biological oxygen demand, taste, odor, alkalinity, temperature, and chlorides. However, from the result it was found that dissolved oxygen ranged from 0.91 - 1.51mg/l and total hardness ranged from 120-200ppm which were above WHO permissible limit. Therefore, the study recommended that such stream water should be used for agricultural purposes such as irrigation. Also, Aryal et al. (2012) carried drinking water quality assessment in Nepal. The study analyzed 84 water samples from natural source, reservoirs and tap water, and matches them with WHO standards. Thus, 15.48% of water samples showed pH (13) higher than the WHO permissible standard. Similarly, 85.71% of

water samples showed higher Arsenic value (72) than WHO value. The result indicated that water samples were within Nepal national standard and WHO standards except arsenic. It was found that coliform contamination to be the key problem with drinking water in the study area.

4. Conclusion

The result from the physico-chemical analysis of water samples were within WHO standard guideline. However, the study revealed that temperature rise of water was the major problem with stream and well waters. This indicated that the waters were not safe for drinking. Thus, it has become imperative for people and authorities living in the urban areas such as Minna Metropolise in Niger State, Nigeria to begin taking action on the availability of quality and sustainable water safe from contamination. The study showed that greater number of the population is at risk of drinking polluted water across the globe. It is therefore, very urgent for governments to initiate quality education on water resources management without further delay.
