The entire article (including figures and tables) should be supplied as a single file.

Format of Typescripts

First page: The first page should also serve as the cover page and should be reserved exclusively for (i) The title of the paper (ii) the name(s) of the author(s) (iii) GSM number and e-mail address of the corresponding author (iv) institutional affiliation of the author(s) and (v) abstract.

The body: (i) Main/section headings should be in title case (e.g. capital letters) (ii) Sub-headings should be in upper case (iii) all sub-headings should be left justified (iv) tables, figures, maps and other illustrations which must be camera-ready should each be numbered and given a title which must be centered (v) all pages should be numbered.

Manuscripts are to be prepared and submitted in word document (.doc) or rich text format. Only manuscripts prepared by MS word 1997-2007 will be accepted for assessment.

Font style: Times New Roman

Font size: 12

Line spacing: double

Abstract and key words

- All articles must have abstract, which should not exceed 250 words. The abstract should contain the research problem, objectives, methodology, findings and recommendations.
- Five key words should be supplied below the abstract in alphabetical order.

Acknowledgement

The source of financial grants and other funding must be acknowledged. The contribution of colleagues and institutions should also be acknowledged. Footnotes can serve this purpose.
