Specifically, the origin of ODL can be traced back to the early 19th century when Isaac Pitman, an Englishman, started a correspondence course on shorthand writing in 1840 (Moore & Kearsley, 2012). This system of writing allowed people to take down notes quickly and accurately. It became popular among business people and secretaries, who used it to record meetings and correspondence. In 1840, Pitman established a correspondence school that taught shorthand writing by mail. This was the first correspondence school in the world and marked the beginning of distance education.

In the early 20th century, the British government established the Open University to provide higher education opportunities to people who could not attend traditional universities. The Open University radio and television broadcasts were used to deliver lectures and provide course materials by mail. Other countries around the world later adopted this model of distance education. In the 1960s and 1970s, technological advances led to the development of new forms of distance education. The advent of the internet and the World Wide Web in the 1990s marked a new era in ODL. The internet made it possible to deliver course materials and provide interactive learning experiences to learners all over the world. However, the development of computers and the internet in the latter half of the 20th century paved the way for the modern era of ODL. In the 1980s and 1990s, online learning management systems and web-based platforms emerged, enabling students to access course materials, engage in discussions, and submit assignments online.

Correspondence courses allowed students to receive learning materials by mail and complete assignments at their own pace without the need to attend traditional classes. By the early 20th century, correspondence courses had become popular in many countries, and the University of London established its External Programme in 1858, which offered students access to degree programs through distance learning (Perraton, 2000). The Open University (OU) in the UK was established in 1969 and became a pioneer in ODL. The success of the OU inspired the development of similar institutions in other countries, including the Open Learning Agency in Canada and the Indira Gandhi National Open University in India (Moore & Kearsley, 2012).

The advent of the internet and digital technologies in the late 20th century revolutionized the field of ODL. Online learning platforms, such as Moodle, Blackboard, and Canvas, provided students with access to learning materials, online discussions, and assessments. Mobile learning, which allows students to access learning materials on their smartphones and tablets, has also gained popularity recently. Today, ODL takes many forms, including fully online courses, blended learning, and massive open online courses (MOOCs). These delivery modes have made education accessible to millions of learners worldwide, regardless of their location or schedule.

Open Distance Learning in Nigeria - A Historical Overview

Open Distance Education in Nigeria has a long history, dating back to the 1940s when the University of London started offering correspondence courses to students in Nigeria. Over the years, distance education has played a critical role in increasing access to education in Nigeria, particularly for people in remote areas who might not have been able to attend traditional face-to-face institutions. In Nigeria, the development of distance education can be traced back to the establishment of the University of London External System in 1947. In 1976, the Nigerian government established the National Teachers' Institute (NTI) to train teachers through the distance learning system. This marked the beginning of the formal distance education system in Nigeria. The NTI initially offered certificate courses but later expanded to offer diploma and degree programmes. In 1983, the government established the National Open University of Nigeria (NOUN) to provide affordable and accessible higher education to Nigerians. The university started as a correspondence institution but later transitioned to a blended learning system that combines face-to-face interactions and online learning. It witnessed a setback a few months after its take-off when the then military government suspended its operation.

The University of Lagos established the Correspondence Open Study Unit (COSU) in 1974 to offer distance education programmes to students who could not attend traditional universities. The Distance Learning Institute (DLI) (the new name of COSU) offers degree programmes in various disciplines and combines online and face-to-face learning. In 1988, the Department of Adult Education, University of Ibadan, Ibadan established the External Studies Programme (ESP), now known as the Distance Learning Centre (DLC), to provide degree programmes to upgrade NCE teachers who aspire to further education.

Since then, ODL has undergone significant development and growth in the country, driven by a variety of factors, including increasing demand for education, advances in technology, and changing government policies. This has enabled many distance institutions to spring up. As of January 2023, there are seventeen approved distance learning institutions by the National University Commission (NUC). The list includes the following:

The National Open University of Nigeria (NOUN) is the primary provider of ODL in the country, but there are concerns about the quality of education it provides.
